Profit (Cl. 1.1.20, 13.3 & 15.6) Whilst the 1999 Red Book entitles the Contractor to recover Cost Plus Profit for various relief events, the amount of profit recoverable under the 2017 Red Book is now set at a default sum of 5% in most circumstances. The Contractor is also now expressly entitled to recover lost profit where Works are omitted or where the Contract is terminated for convenience, although the margin of profit is not stipulated.
